at Station 13 in San Leandro. His final tour concluded on


Fire District. Engineer Derickson served 27 years, most recently

## **Ken Thomey**



# **Connected to Community**

### COVID-19

Alameda County Public Health Department continues to work closely with other Bay Area Public Health Departments and the state to track COVID-19 and provide important information to the community. The ACFD shares information on social media and in person to encourage stopping the surge through avoiding gatherings, staying at home, and only going out for essential activities, wearing a mask and keeping six feet away from others. #### **Contract Extensions Approved**

On December 15, the Alameda County Board of Supervisors, who serves as the ACFD Board of Directors, unanimously approved two 5-year contracts with 5-year extensions for ACFD services provided to the Cities of Newark and Union City.





Retiring Alameda County Supervisor Scott Haggerty joined the Department and Alameda County General Services Agency on December 16 to celebrate the groundbreaking of the Department's new Regional Training Center located adjacent to the existing Fire Station 17 on Gleason Road in Dublin. The new facility will replace the Department's currently 50+ year old site for a safer and more upgraded training center in order to ensure our firefighters have the ability to prepare for reallife emergency scenarios. 


#### Measure X

On December 1, the Alameda County Registrar of Voters certified the results of the 2020 election. Voters in Alameda County's unincorporated communities adopted Measure X, the Fire Safety Bond. Measure X authorizes the Department to issue bonds to repair, upgrade, and replace outdated fire stations in order to maintain fire and emergency medical services in the unincorporated communities of Ashland, Castro Valley Cherryland, Livermore, San Lorenzo and Sunol.

Inadequate funding and aging facilities, including two stations over 50 years old and two over 70 years old, have forced the Alameda County Fire Department to consolidate and close a fire station. Measure X will upgrade existing fire stations and equipment in unincorporated Alameda County communities that rely on the emergency medical lifesaving services, fast 911 response, wildfire protection and disaster response services provided by Alameda County firefighters in local stations.

Measure X includes Independent Citizens Oversight, independent audits, and provides that no money can be spent on salaries, benefits, or pensions of Fire Department employees. Alameda County Regional Emergency Communications Center (ACRECC) officially launched its text to 9-1-1 campaign. Mobile users now have the ability to send text messages to 9-1-1, allowing deaf, hearing and speech impaired residents, or those in situations where it is too dangerous to make a voice call to 9-1-1, a potentially lifesaving option.

"Call if you can -- text if you can't" is the slogan developed by the Federal Communications Commission (FCC), adopted by several California jurisdictions. ACRECC is now equipped to receive and respond to mobile phone SMS Text to 9-1-1 messages, joining other dispatch centers across the state. View important information about the program here.



## Earthquake Warning California

The California Governor's Office of Emergency Services (Cal OES) invites Californians and visitors to join the Earthquake Warning California's "Don't Get Caught Off Guard" earthquake early warning awareness campaign. Earthquake Warning California promotes essential emergency resources to help Californians stay safe in the event of an earthquake. It is the nation's first statewide earthquake warning system and includes no-cost resources:


Earthquake Warning California resources include:

- Information about constructing an emergency plan
- How to protect yourself and your family before, during and after an earthquake
- Android Earthquake Alerts developed in partnership with Cal OES and USGS
- The MyShake App a smartphone app developed in partnership with Cal OES and UC Berkeley that can provide users with a few seconds of notification that shaking is about to occur
- Wireless Emergency Alerts (WEA) free notifications delivered to cell phones in emergency situations
- Information for business sectors to plan for life-saving actions in the event of an alert, such as safely slowing mass transit systems, powering down equipment, or bringing elevators to an emergency stop
- Links to the California Integrated Seismic Network Partners for additional technical and system information

# **Calls for Service**



December 31: At 11:39 am, ACFD with the support of Livermore-Pleasanton Fire Department, Livermore Police Department, and CHP responded to a solo vehicle collision. A single patient crashed and rolled a Jeep on Altamont Pass Road and Greenville Road. The patient was transported in stable condition but suffered significant injuries. Video <u>link</u>.



December 12: Firefighters were dispatched to a single-family home on Palomares Road in Castro Valley on reports of a chimney fire. The fire extended into the attic. Fire sprinklers and ACFD crews quickly knocked down the fire preventing it from spreading into the rest of the home.



December 17: There was a head on collision involving two vehicles on Patterson Pass Road East of Cross Road. One of the two vehicles rolled on to its side. One patient was transported by ground ambulance, and a second patient was extricated and airlifted to the hospital. Video <u>link</u>.



December 25: On Christmas Day, crews responded to reports of an RV fully engulfed in flames in San Lorenzo. One person was transported to the hospital with minor injuries after escaping from the fire.



December 29: ACFD responded to Carnegie motorcycle park for one adult who went over a 50 foot embankment with moderate injuries. Crews safely placed the patient in a stokes basket and used a rope system to haul the patient back up. With assistance from park, the patient was transported to the landing zone where Con Air 2 stood by. Great collaboration between Carnegie SVRA staff, San Joaquin AMR, Contra Costa County Fire and ACFD units. The patient was recovered, transferred and en route within 40 minutes of time of dispatch. 
December 30: ACFD Firefighters and Dublin Police Services responded to a red tail hawk tangled in kite string and stuck in a tree. Firefighters arrived on the scene and performed a unique exercise called an auditorium raise to access the hawk. The firefighter helped cut the kite string with a pike pole which freed the hawk who safely flew away. Video <u>link</u>.



December 9: On Bartlett Avenue in San Lorenzo, crews quickly knocked down a dryer fire, preventing it from extending into the attic and living areas.



December 14: A big rig backed into a loading dock became fully involved at Alvarado Niles Road and Central Avenue in Union City. The fire did not extend into the building. Video <u>link</u>.



December 23: ACFD collaborated with Dublin Police Services, providing a full hazardous materials operation in response to an unknown contaminant at Fallon Middle School. After an extensive search of the school, no hazardous chemicals or materials were located, and the area was deemed safe for re-entry.

During the year 2020, General Services closed out 2049 repair orders for 44 agencies.
