



Important Alameda County Fire Department Measure X Voting Information

MEASURE X INFORMATION

- If enacted, Measure X will repair and upgrade outdated, aging fire stations that are at least 30 years old, including two that are over 70 years old. Doing so will allow the Fire Department to reduce 911 emergency fire and medical response times and enhance wildfire protection and disaster response.
- Measure X requires Independent Citizen Oversight and annual financial audits. No funding can be spent on salaries, benefits, or pensions. By law, all funds are required to be spent locally, and none can be taken by the State.

Alameda County Fire Department Fire Safety Bond.

Shall the measure authorizing the Alameda County Fire Department to issue \$90,000,000 in general obligation bonds to repair/replace outdated stations, thereby maintaining services in unincorporated communities (including medical emergency lifesaving services, fast 911 response, wildfire protection and disaster response) in an estimated levy of 1.6 cents per \$100 assessed value, raising on average \$5,200,000 annually for approximately 31 years, with oversight and audits, and no funds for salaries, benefits or pensions be adopted?

Important Voting Information for the November 3 Election

The Alameda County Registrar of Voters is conducting a different type of election than voters are used to. Please see below for more information.

Vote by Mail Ballots

- All active registered voters should have received a Vote by Mail ballot in October. If you have not received your ballot or need a replacement ballot, contact the Alameda County Registrar of Voters at 510-272-6973 or **acvote.org**. Vote by Mail ballots can be returned by:
 - MAIL - ballots must be postmarked by Election Day, November 3. Remember to sign the back of your postage-paid ballot return envelope.
 - DROP BOX - voters can drop their ballots off at any County drop box location. To find a drop box location, visit **acvote.org/GO**.

Voters can also track their ballot by signing up for the Where's My Ballot tracking tool: **acvote.org/GO**.

Voting in Person

- In-person Accessible Voting Locations will be open in Alameda County beginning October 31 through Election Day. There will be 100 Accessible Voting Locations throughout the County, which any voter can visit to vote or drop off their ballot.
- Accessible Voting Locations will be open October 31 - November 2 from 9am-5pm and on November 3 (Election Day) from 7am-8pm.
